

## TERMS AND CONDITIONS OF HINDUSTAN COACHING SCHOLARSHIP

Welcome to **HINDUSTAN COACHING SCHOLARSHIP**- for coaching students for Engineering & Medical entrance examinations initiated by HT Media Ltd ("HTML") in association with **BRILLIANT TUTORIALS PVT LTD (BRILLIANT TUTORIALS)**. You must go through the following Terms and Conditions. By participating in the **HINDUSTAN COACHING SCHOLARSHIP program**, you agree to be bound by these Terms and Conditions or any subsequent future amendments. HTML reserves the right, in its sole discretion, to amend or revise these terms and conditions at any point of time, without prior notice and you agree to be bound by such amendments or revisions.

1. The **HINDUSTAN COACHING SCHOLARSHIP Test** will be held on 5<sup>th</sup> July 2009.

1.1. Participation in the above said programme is restricted to students having Financial background: Net Monthly Household Take home Income (MHI) after tax deduction to be equal to or less than Rs. 20, 000/- (net take home income of the earner)

1.2. The candidate ,must be a class 10 pass out in March 2009

1.3. The candidate must be a Class 10 Pass out from any school located in the states of Jharkhand, Bihar, Uttar Pradesh, Uttrakhand or Delhi only. No correspondence shall be entered to those who don't fulfill this criteria

2. Employees of HTML, associated third party and their immediate family members and relatives are not eligible to participate in this **scholarship** programme

2.1 The registration forms for the test shall be printed in our newspaper **(Hindustan-All editions except Chandigarh) on 13<sup>th</sup> ,14<sup>th</sup>, 17<sup>th</sup>, 20<sup>th</sup>, 21<sup>st</sup>, 24<sup>th</sup> and 27<sup>th</sup> of June, 2009**

3. Admit cards shall be given on submission of the registration form after verification of the same. Incase the registration form is received by post /speed post/ register post, the admit card shall be sent via post/speed post/register post
4. Students need to submit DD of Rs 250/- along with filled registration form. DD should be in favor of "Brilliant Tutorials Pvt. Ltd" payable at Delhi
5. Once the participants/students have done this, the requisite team of **BRILLIANT TUTORIALS** shall sort out the registration forms for the eligible candidates. Admit cards will be sent only to eligible students. Eligibility criteria to be decided by **BRILLIANT TUTORIALS** in association with HTML

The arbitral tribunal shall consist of a sole arbitrator to be appointed by **HTML**. The venue of arbitration shall be New Delhi and the proceedings of such arbitration shall be in English Language only.
26. All disputes shall be subject to the exclusive jurisdiction of **DELHI** Courts only.
27. **HTML** in its absolute discretion reserves the right to add, alter, modify, change or vary all or any of these Terms & Conditions, wholly or in part, at anytime without giving any prior notice and the participant/selected candidate agrees to abide by such additions, alterations, modifications and changes.
