### **PUBLIC NOTICE**

This is to notify all concerned that the Commission is conducting recruitment to the posts of Assistant Teachers [for class levels IX-X and XI-XII] and Non-Teaching Staff [both Clerk and Group D] in compliance with the solemn direction of the Hon'ble Supreme Court in CA No. 9586 of 2024 (and other connected matters) in a time-bound manner.

**Whereas**, pursuant to the advertisement dated 30.05.25 (wherein applications were sought for 11 subjects for class level IX-X and for 36 subjects for the class level XI-XII), the written examinations for the teaching posts (both class levels IX-X and XI-XII) have been conducted on 07.09.25 and 14.09.25 and after completion of interview-cum-lecture demonstration for class level XI-XII, the panel and waiting list for all subjects have been published for the class level XI-XII on 21.01.26. The written examinations for the posts of Clerk and Group D were held on 01.03.26 and 08.03.26, respectively.

**Whereas**, counselling for issuance of recommendation letters for the post of Assistant Teachers for classes XI-XII has commenced from 24.02.26 and **seven** subjects have already been fully covered so far.

Whereas, the Commission, in an earnest effort to comply with the time limit (for completion of the recruitment process) set by the Hon'ble Supreme Court in respect of the Teaching posts (both class levels IX-X and XI-XII), publishes the following tentative schedule for the remaining work for the Teaching sector.

It is reiterated that the selection process will depend upon the outcome of the pending Writ Petition being WPA 12434 of 2025, as notified vide Commission's memo no 2231/L9430/CSSC/ESST/2025 dated 04.12.2025. It is further stated that the tentative schedule is subject to some minor changes due to unforeseen and unavoidable circumstances. Such changes, if any, will be notified well in advance on the Commission's website.
