

India vs Sri Lanka Predictor- TERMS & CONDITIONS (T&C)

THESE TERMS & CONDITIONS (HEREINAFTER REFERRED TO AS THE “T&C”) ARE APPLICABLE TO ALL THE PARTICIPANTS/CONTESTANTS OF THE “INDIA VS SRI LANKA PREDICTOR” PROMOTED / ORGANIZED BY M/S HT DIGITAL STREAMS LTD (HTDS).

1. The India vs Sri Lanka ODI Cricket Match Series Quiz Contest or India v Sri Lanka Predictor to be held between 31st July’24 to 7th Aug’24 (hereinafter referred to as “Contest”) is being conducted on the Hindustan Times websites (“Website”).
2. All the residents of India will be eligible to participate in the Contest, irrespective of their region of residence, gender, caste, religion, etc.
3. A question will be posted on the days of India matches.
4. There could be various entry points for the Contest, for e.g. social media, but the user can participate only on the Website.
5. **Contest Duration:**
 - The Contest will commence on 31st July’24 and conclude on 7th Aug’24.
 - The time of posting questions and duration of the Contest may be subject to change at the discretion of HTDS.
6. **Contest details:**
 1. To participate in the Contest, participants will be required to answer the questions & provide accurate and complete information, including their name, age, contact number, and email address, when submitting their entries.
 2. All person under the age of 18 years will be ineligible for Participation.
 3. Incomplete or partially correct entries will not be accepted/considered.
 4. The contest question can be updated anytime during the day at the sole discretion of HTDS.
 5. Entries must be submitted within the specified contest duration each day.
 6. Each participant can submit only one entry per question for the entire duration of the Contest.
 7. HTDS reserves the right to verify the eligibility of participants and their entries.
7. **Winner selection details:**
 1. Out of all the valid entries received every day, a leaderboard will be created, on which all participants with correct answers will be ranked.
 2. Points on the leaderboard shall be allocated to each participant for every correct answer. Ranking shall be determined based on the chronological order of correct answer, submissions with the earliest correct answers receiving a higher ranking.
 3. A winner will be selected for each match day during the Contest duration based on the correct entries received that day, through a lucky draw that will be solely conducted and managed by HTDS. Based on the leaderboard standing, there will also be a jackpot reward, details for which are mentioned under Section 8 (prize details).
 4. Leaderboard will also be constantly displayed on the website.

5. The winners will only be selected on working days (Monday-Friday). For all the holidays and weekly off days, winners will be selected on the next working day.
6. Winners will be contacted within 03-04 working days after the draw via a phone call and/or an email sent to the email address provided during entry submission.
7. To claim the prize, winners must acknowledge receipt of the communication and provide written acceptance within 24 hours by replying to the email using the same email address from which they received the communication.
8. The acceptance email should also contain details like phone number, address, a soft copy of winner's identification document, i.e, either Voter ID, Aadhar, PAN or driving license.
9. Failure to acknowledge receipt and provide written acceptance within the stipulated time period will result in the forfeiture of the prize.
10. In case of communication by way of phone call, only one attempt shall be made to contact the winner on his/her mobile number. In the event of non-availability of the concerned winner, the prize shall lapse.
11. Upon receipt of the acknowledgment, further instructions regarding prize collection or delivery will be provided to the winners.
12. HTDS shall reserve the right to select any alternate winner in the event the prize cannot be given to the original winner.
13. Winner testimonials regarding their experience will also be collected & some of them will be shared on social media handles and print editions.
14. This can include written testimonials and their images along with their prize.
15. Winners are responsible for providing accurate and complete delivery address details during the acknowledgment process.
16. The delivery timeline may vary depending on the availability of the prize and the logistics of the vendor responsible for prizes.
17. HTDS shall not be held liable for any delay, loss, or damage occurring during the delivery process.

2. Winners will be selected only for match days in the series.
3. At sole discretion of HTDS, Voucher codes might be given for all correct predictions on each match day during the Contest.
4. Each Voucher code shall be subject to its respective terms and conditions.
5. Each Voucher code shall be valid for a single use per winner.
6. HTDS responsibility shall be limited to convey Voucher codes to the winners and HTDS holds no other responsibility for the same.
7. In the event of any unforeseen circumstances, HTDS reserves the sole right to offer an alternative prize.

8. Jackpot Reward:

2 (Two) Nights 3 (Three) Days Stay in Goa for 2 people (i.e., winner plus one person of his/her choice) awarded to winner of the Contest predictor leaderboard winner (one winner only) as per below:

- HTDS, in its absolute discretion may broadcast or otherwise disclose a participant's/winner's name, character, likeness, statements, or any recording of their voice in advertising or promotional activities concerning this competition, or generally and participant's/winner's name shall have no objection to the same. HTDS reserves the right to promote or advertise that a winner has won the Contest.
- HTDS reserves the right to disqualify any participant/winner if it has reasonable grounds to believe the participant/winner has breached any of these T&C.
- HTDS, its vendor and/or its subsidiaries shall not be liable to any person or entity for any direct, indirect, incidental, special, punitive or consequential damages, including loss of profits, incurred by the winner or any third party, whether in connection with this Contest, or for breach of any warranty or in tort.

- Communication: All communication regarding the contest shall be conducted via the official channels designated by HTDS. Participants are responsible for regularly checking these channels for updates and announcements.
- Independent Contractor: Nothing in these terms and conditions shall be construed as creating a partnership, joint venture, employment, or agency relationship between participants and HTDS. Participants shall have no authority to bind HTDS or incur any obligations on its behalf.
